## Interfaith Advocacy Day 2009 will advocate for those hit hard by economic crisis Representatives of many faiths will gather at state capitol on Thursday, Feb. 19

In the midst a growing economic downturn that threatens to impoverish many Oregon families, members of diverse religious communities are planning to converge on Salem on Feb. 19 for *Interfaith Advocacy Day 2009.* This event will bring together people from many faiths to advocate for programs to combat homelessness, reduce hunger, and provide expanded access to affordable health care for children and low-income adults. The theme for 2009 is "Faithful to Oregon's Future." The event will be held from 8 a.m. to 4 p.m. at St. Mark Lutheran Church, 790 Marion St. NE, and the Oregon State Capitol building. More than 300 people are expected to participate.

*Interfaith Advocacy Day 2009* will include worship, advocacy and issue trainings, a keynote address from House Speaker Dave Hunt, and prayer and reflection. After lunch, participants will march to the Capitol where they will meet with their legislators, after being welcomed to the Capitol by Senator Laurie Monnes-Anderson and Rep. Scott Bruun.

In addition to Speaker Hunt, other confirmed speakers include Bob Horenstein, Jewish Federation of Greater Portland; Cathy Kaufman, Children First for Oregon; Michael Anderson, Oregon Opportunity Network; Stephanie Tama-Sweet, Oregon Food Bank; David Leslie, Ecumenical Ministries of Oregon; and the Rev. Shelley Willem, St. Mark Lutheran Church.
